# Growth on the Horizon

#### **COMMUNITY LAND TRUST:**

A visionary approach to solving the need for housing

As housing costs continue to rise, Barry County is exploring new ways to make homeownership more accessible without compromising long-term community stability. One strategy is the introduction of a community land trust.

A community land trust is different from the traditional real estate model. With a land trust, the land

remains owned by a public or nonprofit entity, while the homeowner owns only the house itself. This

model reduces the upfront cost and removes the burden of property taxes tied to the land. This program makes home ownership more affordable for families who might otherwise be priced out of the market.

Land trust homes come with built-in protections. Buyers can build equity in the home, but resale restrictions ensure the home remains affordable for the next owner. That way, the trust preserves long-term affordability across decades, rather than just serving one homeowner at a time. As an added benefit, the trust doesn't require homes to be located next to one another; it's a flexible model that can work across an entire county.

Looking ahead, the community is optimistic about the impact the land trust model could bring. Barry County aims to create a sustainable path to homeownership that prioritizes affordability. The land trust represents a step toward ensuring that families can build roots here for generations to come.

# Cultivating Community NASHVILLE'S COMMUNITY HEART & SOUL

At its core, Community Heart & Soul is about capturing the values and hopes of citizens to shape a future to reflect their vision. Nashville's journey with this process is well underway, as the town progresses through Phase 2 of the four-part Heart & Soul process: Imagine, Connect, Plan, and Act. This year, local leaders and volunteers have been busy gathering stories from residents about what they love, what improvements they want to see, and what they hope for their town's future. The focus is on connecting with residents of all ages and backgrounds to understand what matters most to them. These community stories will ultimately guide future planning and investment.

Duska Brumm, a Nashville resident and BCF Program Officer, says this program is pivotal to the town's future. "By listening to one another's stories, we are building a shared vision of what matters most to our people," she said.

The team has gathered stories from places like the high school, the antique festival, and the public library. Already, one common theme is emerging: residents value Nashville's sense of a close-knit community. Eventually, these stories will help shape local improvements. Suggestions so far include downtown renovations, new festivals or events, and shared gathering spaces like a community pavilion.

"Through collective efforts, we can build a future on what Nashville residents dream for their own community," Brumm added.

Maple Valley Scholarship





There are different ways to leave a legacy. Some people spend a lifetime building theirs. Others are honored by those who want to ensure their memory lives on in meaningful ways. For Guenther Mittelstaedt, both are true.

Guenther Mittelstaedt began teaching at Maple Valley Junior-Senior High School in 1973. A German immigrant and first-generation college graduate, he brought with him a passion for history, geography, and athletics. For more than 35 years, he shaped the lives of Maple Valley students as both a teacher and a coach. Whether he was leading a varsity football team to the state finals or pion high students in the classroom. Coach Mittelstandt

encouraging junior high students in the classroom, Coach Mittelstaedt was known for his unwavering belief in young people's potential.

When Guenther passed away in May of 2025, the Maple Valley community lost not only a beloved educator and coach, but a neighbor and friend as well. His life is a reminder that one person's dedication can leave a lasting mark on an entire community. To honor that impact, his family created the Guenther Mittelstaedt Memorial Scholarship, which will begin awarding its first recipient in 2026.

Even though Guenther eventually relocated upon retirement, the hearts of his family remain tied to the place where he spent so much of his life. Creating this scholarship was their way of ensuring his influence and values continue to shape future generations. At the Barry Community Foundation, we see time and again how families choose to honor loved ones in ways that give back, turning personal legacies into opportunities for others to succeed.

#### Harvesting Local Bounty

#### MILL STREET MARKET

In Hastings, a new community-driven food and wellness project is sprouting. Mill Street Market is a 10,000-square-foot community food center on track to open in the summer of 2026. Envisioned as a hub for fresh food, childcare, and healthy living, this Barry Community Foundation project is led by Executive Director Allison Hinton, and is supported by the B. Healthy initiative.

This \$3.8 million project has big goals: support local farmers and food producers, expand access to nutritious food, provide affordable daycare, and offer a licensed commercial kitchen for food-based businesses to grow.

"We're giving farmers, food makers, and families the tools they need to grow," explained Hinton. Farmers and producers will consign their goods and receive 70% of the proceeds, which, in comparison, is more than the narrow profits they often receive through traditional distribution channels.

Mill Street Market will staff the storefront, manage Inventory, and handle sales so local producers can spend more time growing. The building will include a retail market and an on-site café, serving fresh coffee and food made with local ingredients. The other half of the space will house a childcare center aimed at being affordable to Barry County families while offering competitive wages to its staff.

This model allows local producers to sell their fresh products while extending their business opportunities. By processing, storing, and repurposing their goods on-site, farmers and entrepreneurs are supported every step of the way.

HUNDREDS OF AREA STUDENTS RECEIVE SCHOLARSHIPS EVERY YEAR Every spring, students of Barry County are awarded scholarships to support their next career-focused steps, wherever that may lead them.

The Barry Community Foundation partners with the Thornapple
Area Enrichment Foundation and the Delton Kellogg Education
Foundation to provide a robust scholarship program for
Barry County students, which is indicative of what
happens when a community believes in its people
and invests in their future potential. Currently, 150
different scholarships are available to help students
pursue their passions.

With more than 100 volunteers reviewing hundreds of applications, the scholarship program is built on fairness, thoughtfulness, and donor intention. The volunteers' protocol ensures each foundation adheres to strict IRS guidelines for charitable giving. Behind every scholarship is a donor, family, or business that trusts the foundation to steward their generosity.

Some recipients will pursue four-year degrees. Others will enter trade schools, certificate programs, or head straight into the workforce. These scholarships are investments in people, not just diplomas. Some may return to reside in Barry County. Others may build lives far away. But no matter where they land, their lives have been positively impacted and supported by the community from where they came.

### Sprouting New Leaders

LEADERSHIP BARRY COUNTY YOUTH QUEST

Each summer, a small group of high school students from across Barry County gather at YMCA's Camp Algonquin to take part in Youth Quest, a program that teaches leadership, teambuilding, and creative problem solving. Led by a team of facilitators, Youth Quest serves as a deliberate effort to help teens grow into stronger leaders. This year's group included six students from Hastings, four from Maple Valley, and two from Thornapple Kellogg.

"We definitely want to get more students involved," said Dave Solmes, longtime facilitator, "and the main goal of Youth Quest is to get kids from all different backgrounds." Solmes emphasized that Youth Quest isn't just for natural leaders or straight-A students; it's designed to reach a wide and diverse mix of individuals, especially those who might one day give back to Barry County.

During the weekend, students work through problem-solving activities and group challenges technology-free. The goal is to encourage connection, collaboration, and to learn how to work with those who bring different perspectives than they do. Although many students arrive not knowing each other, they leave having formed strong bonds.

"Youth Quest had me do things I thought were impossible for me to accomplish, pushing me to greater heights both physically and mentally. I learned how to work patiently with a team, how to communicate well, and the importance of optimism. I believe we all grew differently over camp, but by the end of it, we left with a sturdy understanding of good leadership," explained Shannon Kistler, 2025 Youth Quest Participant.

Youth Quest is a meaningful part of Barry County's youth development and will continue to equip young leaders with the skills they need to succeed. Whether they return to their hometowns or move on to new places, Youth Quest alumni carry with them the value of leadership and community.

# Enjoying the Beauty of Our County COMMUNITY GRANTS IMPROVE ACCESSIBILITY TO LAKES AND PARKS

In Barry County, outdoor adventures are becoming more accessible through community grants that help open outdoor experiences to everyone. Two recent initiatives supported by the Barry Community Foundation are leading the way: an all-terrain track chair at Historic Charlton Park and an adaptive kayak launch at Camp Manitou-Lin.

At Charlton Park, a \$10,000 grant from BCF helped fund the purchase of an all-terrain wheelchair. Offered free of charge, the chair allows individuals with mobility challenges to explore areas of the park's historic grounds and trails with greater freedom.

Charlton Park staff have been testing the track chair on different trails to determine suitability for access. Part of this planning is pre-determining various routes for novice versus experienced users. The park has plans for demonstrations at Barry ISD, Thornapple Manor, the Commission on Aging, and any other group that requests a demonstration for potential users.

"We want people to know this is a resource for those who need mobility assistance and enjoy the outdoors," said Dan Patton, Barry County Parks Director.

At Camp Manitou–Lin, a new adaptive kayak launch is opening the lake to even more people. The specially designed equipment allows individuals with physical limitations to safely transfer into kayaks. With this addition, campers of all abilities can now experience kayaking on Barlow Lake. This upgrade is already making a difference in the lives of campers and stands as a model for future accessibility efforts across the region.

#### Thought Garden

A SEED OF AN IDEA PROVIDES FRESH FOOD

Since 2001, the Fresh Food Initiative has served as a vital resource in Barry County, providing fresh food to hundreds of households each week. The program, coordinated through the Barry County United Way, aims to connect local families with healthy food options in a welcoming, accessible way. Each week, nearly 250 households receive boxes of fresh food through a drive-through model, based in the parking lot of the Green Street Methodist Church in Hastings. Volunteers help unload 10–15,000 pounds of food each week, fill boxes, and distribute them to community members.

The program's roots trace back to a small but meaningful investment. One of the Fresh Food Initiative's earliest supporters was the Barry Community Foundation, which issued a \$1,000 grant to South Central Food Bank, where the food is still purchased from today. That initial funding helped spark what would become a lasting partnership. In 2001, BCF granted \$2,000 to launch the Fresh Food Initiative site here in Barry County.

Many assistance programs have eligibility requirements, which can leave out people who may not qualify on paper, but still experience food insecurity. The Fresh Food Initiative helps bridge that gap by offering fresh food to anyone in need, no questions asked.

"We know this program is an asset to our community as it is the only non-income-qualifying food program in Barry County," says Morgan Johnson, Barry County United Way Fresh Food Initiative coordinator. "The community foundation is always our biggest support system, and we know that together, we can make incredible things happen."



## Nourishing Future Growth INVEST BARRY—The Local Grind

Invest Barry has fueled growth at The Local Grind, a coffee shop in Delton that serves as a welcoming gathering place for coffee enjoyers as well as students, neighbors, and anyone looking for a friendly space to work, relax, or spend time with friends.

An Invest Barry loan helped create new opportunities for The Local Grind to grow and serve, keeping energy and enterprise right here at home. That's what Invest Barry is all about: supporting the economic strength of Barry County through mission-driven investment strategies. The program ensures that money made in Barry County stays in Barry County. By offering low-interest loans, it lowers the barrier for local entrepreneurs to grow their businesses, while repayments cycle back into the fund to support future investments.

Through the loan, The Local Grind was able to install a commercial kitchen, which opened the door to a new menu of fresh-baked goods and food items. Other much-needed renovations throughout their space, including new siding, were made possible with the funds from this Invest Barry loan.

Kristina Harrington, the owner of the shop, says the loan has been essential to their growth, supporting everything from food preparation to day-to-day operations. "We often say, how did we ever do this before?" she said.

The story of The Local Grind is one rooted in community spirit. Even the space itself tells that story. Nearly every table, chair, and decoration has been donated or passed along by friends, customers, and supporters who love the shop and want to see it thrive. It's a space shaped by the people who care about it; where every detail reflects the community's belief in the value of local business.


# Planting a Forest of New Housing update

Across Barry County, new housing investments will serve the needs of residents and increase affordable and attainable housing.

Currently, in Barry County, nearly 150 new housing units are either in planning or under construction. One of the most exciting projects is under construction on Mill Street in Hastings. Through Michigan's bipartisan redevelopment program, Hastings has secured funding to transform long-vacant lots into housing and shared community spaces. The Riverwalk Lofts will consist of three multifamily buildings with a total of 135 residential units, with an additional building serving as the Mill Street Market.

We've also partnered with local craftsman, Jason Tietz, to introduce Shuffle Houses. These are single-level homes under 1,200 square feet, designed for someone to be able to "shuffle" through the home without any change in elevation. These homes are perfect for first-time buyers or those looking to downsize. To date, there are seven Shuffle Houses in our county: three complete and four in the planning stage.

As these homes help to fill Barry County's urgent need for housing, we're excited to continue creating opportunities for people to live affordably throughout the community.




